

# Twin Bridges Recycling and Disposal Facility

Twin Bridges Recycling and Disposal Facility (RDF) is a regional facility that provides safe and convenient disposal services for communities, businesses and industries serving Hendricks County and surrounding areas.

Waste Management's approximately 300 disposal facilities employ the latest advances in landfill technology. This facility is engineered with environmental protection systems that meet or exceed rigorous government regulations and are subject to highly regulated monitoring and reporting requirements. Systems include engineered liners and covers, leachate collection and removal, and landfill gas collection and control.

# **Containment Design**

Twin Bridges RDF utilizes a double-layer, 3-foot compacted clay liner with a 60-mil high-density polyethelyne (HDPE) geosynthetic liner to ensure that waste and wastewater (leachate) are contained and isolated from soil and groundwater.

# Leachate Collection & Treatment

Leachate is managed onsite using manmade wetlands technology, discharged to a local Publicly Owned Treatment Works (POTW), as well as, recirculated throughout portions of the landfill.

# Groundwater Monitoring

Groundwater is monitored at 7 wells, which are upgradient and downgradient of the waste disposal footprint. The groundwater monitoring network is sampled and analyzed semi-annually in accordance with the procedures of the facility's groundwater sampling and analysis plan.

# Landfill Gas Management

Twin Bridges RDF collects and manages landfill gas through an extensive flare system, which reduces emissions and minimizes odor. In addition, landfill gas is actively extracted throughout the landfill and piped to onsite gas-to-energy plants, which is then sent to the local power grid.

# Security

Site security is ensured by controlled, limited access to the facility through the gatehouse as well as perimeter fencing and natural barriers. During non-business hours the gate is locked and monitored by 24-hour electronic surveillance.

### **Community Partnerships and Involvement**

Twin Bridges RDF is proud to be an active supporter of community events and programs that make Hendricks County and its surrounding cities a strong and healthy place to live, work and play.

As part of a major expansion of the landfill, Twin Bridges has entered into an agreement with the Town of Danville to create about 250 acres of recreational amenities, including a golf course, soccer fields, police shooting range, skeet shooting area and softball fields. Waste Management also maintains about three miles of trails through the site for hiking and horseback riding. The remainder of the site and some of the closed sections of the landfill are operated as a nature sanctuary.

Throughout the site are several miles of trails, established and maintained by staff volunteers and community partners, the most involved of which is the local Boy Scouts. These trails are recognized by the Town of Danville, and as they grow more extensive over time they will soon connect with the countywide and town wide systems of trails to be used by the general public.

Twin Bridges RDF is a Wildlife Habitat Council Certified site implementing projects dedicated to preserving native wildlife. In addition, the site holds the Corporate Lands for Learning Certification for its on-going commitment to environmental education.

Twin Bridges also offers a site tour program – providing free tours for schools, colleges, and local groups to educate all ages about the sophisticated technology utilized in today's landfills.
