Woodland Meadows Recycling and Disposal Facility

Woodland Meadows Recycling and Disposal Facility (RDF) is a regional facility that provides safe and convenient disposal services for communities, businesses and industries serving the Detroit Metro and surrounding areas.

Waste Management's approximately 300 disposal facilities employ the latest advances in landfill technology. This facility is engineered with environmental protection systems that meet or exceed rigorous government regulations and are subject to highly regulated monitoring and reporting requirements. Systems include engineered liners and covers, leachate collection and removal, and landfill gas collection and control.

Containment Design

Woodland Meadows RDF utilizes a a containment system comprised of a 10 foot natural clay barrier with a 2-foot thick re-compacted clay liner or geo-synthetic clay liner (GCL), a 60-mil high density polyethylene (HDPE) liner, a 16 ounce protective geotextile cushion and a leachate collection system. Leachate is a combination of precipitation mixed with the liquid generated by waste as it decomposes.

Leachate Collection & Treatment

Leachate is managed onsite and is discharged to a local Waste Water Treatment Plant (WWTP).

Groundwater Monitoring

Groundwater is monitored at 18 wells, which are upgradient and downgradient of the waste disposal footprint. The groundwater monitoring network is sampled and analyzed semi-annually in accordance with the procedures of the facility's groundwater sampling and analysis plan.

Landfill Gas Management

Woodland Meadows RDF collects and manages landfill gas through an extensive flare system, which reduces emissions and minimizes odor. In addition, methane is recovered from the landfill gas and used as fuel at a local auto assembly plant.

Security

Site security is ensured by controlled, limited access to the facility through the gatehouse and perimeter fencing. During non-business hours the gate is locked and monitored by 24-hour electronic surveillance.
