

SUBURBAN LANDFILL

Suburban Landfill is a regional facility that provides safe, and convenient disposal services for communities, businesses and industries serving Perry County and surrounding areas.

WM's approximately 300 disposal facilities employ the latest advances in landfill technology. This facility is engineered with environmental protection systems that meet or exceed rigorous government regulations and are subject to highly regulated monitoring and reporting requirements. Systems include engineered liners and covers, leachate collection and removal, and landfill gas collection and control.

Containment Design

Suburban Landfill utilizes a single-layer, 60-mil textured high-density polyethylene (HDPE) liner to ensure that waste and leachate are contained and isolated from soil and groundwater. Leachate is a combination of precipitation mixed with the liquid generated by waste as it decomposes.

Leachate Collection and Treatment

Leachate is managed onsite and transported via truck to a local wastewater treatment plant (WWTP).

Groundwater Monitoring

Groundwater is monitored at 9 wells, which are upgradient and downgradient of the waste disposal footprint. The groundwater monitoring network is sampled and analyzed semi-annually in accordance with the procedures of the facility's groundwater sampling and analysis plan.

Landfill Gas Management

At Suburban Landfill, landfill gas is actively extracted and converted to electricity in our landfill gas-to-energy plant. The energy produced is then sent to the grid at South Central Power, in Southeastern Ohio, and provides enough energy to power over 2,000 homes. In addition, excess gas is managed through a flare system, which reduces emissions and minimizes odor.

Security

Site security is ensured by controlled, limited access to the facility through the gatehouse as well as perimeter fencing and natural barriers. During non-business hours the gate is locked and monitored by 24-hour electronic surveillance.
